ELIGIBILITY OF EXPENSE TYPE

25% of disqualified transactions are due to ineligible expenses, such as restaurant meals in the Netherlands and employee hotel stays in France.



BREAKDOWN OF MULTIPLE ITEMS

One receipt cannot be submitted for multiple items of different VAT/GST rates, such as accommodation, food, and hotel parking.



DUPLICATE & INCOMPLETE DATA

Almost half of all ineligible transactions are either duplicates of receipts or receipts submitted without dates, currency, company name, and other identifying compliance information.




